- Tara gave numbers
 - ☐ Hinsdale:
 - o 700 doses received
 - o 360 1st round doses given
 - o 313 2nd round doses given
 - o 30 to be given today
 - ☐ Mineral:
 - o 800 doses received
 - o 470 1st round doses given
 - o 360 2nd round doses given
- Mineral did not receive a current shipment, so they are encouraging community members to go to the clinic in Sargent.
- Governor opened vaccine distribution to general population on 4/2, which is making it much easier to schedule.

State Dial

- Both counties in green
- There is no longer a capacity limit indoors, but there are still distancing requirements so that will impact capacity
- Started community driven messaging to encourage events to plan/stay safe.

Personnel Policy Handbook

- Holding out for approval until Hinsdale County approves the Handbook for the county, as some of the wording needs to be the same in both handbooks.
- Lynn McNitt reviewed the Handbook and only had a few grammatical changes
- The Vaccine Mandate was updated: PH will get authorization from the employee to let client know they have not been vaccinated. If employee consents, PH will inform the client that the employee is not vaccinated and client can make decision to have employee in their home or not.
- New policy to firm-up new moms bringing new child to work. Something that has always been done, but now it will be in the handbook.
- Once the Hinsdale handbook is finalized the BOH can approve PH Handbook.
